The Punjab Public Service Commission invites <u>Online Application Forms</u> from eligible Candidates for recruitment to <u>Six Posts of District Welfare Officer</u> in the Department of Welfare of Scheduled Castes and Backward Classes, Government of Punjab.

2.0 **PAY SCALE**: Rs. 10300-34800 + 5000/- Grade Pay.

Regarding drawing the pay of the appointed candidate, <u>as per Notifications No. 7/204/2012-4FP1/66</u>, <u>Dated 15/01/2015 of Govt. of Punjab Department of Finance (Finance Personnel-I Branch)</u> <u>Chandigarh, fixed emolument equal to Minimum of the Pay Band i.e. Rs. 10300/- without any Grade Pay or any allowance will be paid during the probation period of 2 years</u>. It is also clear that Annual increment or any other allowance except travelling allowance will not be paid during the probation period of 2 years.

3.0 ESSENTIAL QUALIFICATIONS :-

- i) Graduate of a recognized University with at least 5 years experience as Social Worker especially amongst the Scheduled Castes and Backward Classes. The candidate having qualification of M.A. in the subject falling under the classification of 'Social Sciences' or Sociology and possessing Technical Knowledge experience in the field of Social Welfare Department's activities will be given preference.
- ii) Punjabi of Matriculation or its equivalent standard.

(Relaxable for Sikh Migrants to the extent that they will have to acquire such qualification within two years after joining the service failing which their services shall liable to be terminated)

Important Note:

The candidates MUST possess the requisite qualification mentioned at para 3 (i) and (ii) above on or before 19/03/2015 (i.e. The Last date of Submission of Online Application Forms.) During various stages of selection process, the candidature of the candidate shall be 'purely provisional' subject to his/her fulfilling the eligibility criteria and verification of documents by the Commission.

4.0 <u>AGE</u>

- (i) Candidates should not be below 21 years and above 37 years of age as on <u>19/03/2015</u> (i.e. The Last date of Submission of Online Application Forms.)
- (ii) Upper age limit may be relaxed up to 45 years for all States/ Central Government employees.
- (iii) The Upper age limit is relaxed upto 42 years for Scheduled Castes and Backward Classes of Punjab.
- (iv) Ex-servicemen of Punjab Domicile shall be allowed to deduct the period of his service in the Armed Forces of Union from his actual age and if the resultant age does not exceed the maximum age limit prescribed for direct appointment to such a vacancy in the Service Rules concerned by more than three years, he shall be deemed to satisfy the condition regarding age limit.
- (v) Upper age limit is also relaxable upto 42 years for Widows, Divorcees and certain other Categories of Women.
- (vi) Upper age limit is also relaxed upto 47 years for Physically Handicapped of Punjab.
